## ST WINEFRIDE'S CHURCH, KEW GARDENS NOTES TO THE ACCOUNTS FOR THE YEAR ENDED 31st DECEMBER 2022

- a) These accounts show <u>Parish</u> income / expense only and exclude amounts totalling £21,931 (2021 £12,683) raised for 2nd collections for the Diocese and other third parties, and Christmas and Easter offerings.
- b) 70% of the Offertory is paid by Standing Order (2021 66%), 16% is Loose (cash or cheque) (2021 27%) and 14% is now via contactless giving (2021 7%).
- We introduced contactless giving in June 2021 and the total amount raised via DONA from June 2021 to December 2022 is £27,400. (£15,817 Parish income, £11,583 third party / 2nd collections etc.)
- c) Gift aid is claimed on a monthly basis. The % of our 2022 Parish income which was gift aided was 80% (2021 81%).
- d) Hall hire has increased further since the easing of Covid restrictions.
- e) This includes installation of security gates, the new Church noticeboard, the temporary access ramp, minor repairs and routine maintenance.
- f) The Parish belongs to the Diocesan Fuel Management Scheme which negotiates & manages fuel contracts on our behalf. New one year contracts were agreed for electricity effective 1st July 2022 and for gas effective 1st October 2022 with prices roughly tripling.
- g) This includes salaries for Parish Secretary, Caretaker & Organist and cost relating to Fr George who joined us in August 2022 to assist fr Brian.
- h) The Diocese has little income of its own and so levies a percentage of Parish income to cover costs incurred at Diocesan level. Catholic parishes are expected to be financially self sufficient receiving no income from the Diocese or the Government.
- i) The money loaned to the Diocese has been built up over the years the majority coming from two large legacies.

  Although it makes the Parish look wealthy, and we <u>can</u> draw on it to support our annual running costs, it is intended for capital projects to maintain & improve the Parish estate.

There are minor differences between the 2021 figures shown above and those published last year. This is because of reconciliation work carried out on the new Diocesan accounting system.
